Symposium Theme: Developing Equitable Future-Ready Education Systems

Surrey Schools will serve as a case study to frame our discussions. We will focus on their system successes, emerging learnings, and challenges with a focus on their unique COVID response and implications for schooling in its aftermath. We will also investigate more deeply Surrey's competency-based curriculum; digital portfolio systems; and leadership coaching culture.

Sub-themes:

- 1. Learning Ecosystem: Multiple Modes of Learning What is the future of learning in hybrid and blended modalities? Learning takes place in multiple places with multiple people; it is no longer digital versus non-digital.
- 2. Social Emotional Learning (SEL) In a COVID world, mental health and wellness is more important than ever. How are SEL and 21st century skills being implemented across whole school systems?
- 3. The Teaching Profession
 - Systems need a specialized, differentiated workforce of educators. What does it mean to be an educator in the current environment?
 - During the emergency COVID response, the systems that fared the best are those that empowered teachers as creative professionals. What does this tell us about how systems can best adapt to unexpected disruptions?
- 4. Assessment, Recognition, and Credentialing
 How do we broaden our assessment and credentialing systems? What are best practice
 examples from GCEN members as well as from around the world?

- 1. Support and Dialogue: Discussion and feedback with the GCEN network.
- 2. Spread of Learning: Sharing lessons, adaptations, and best practice with other districts focused on the above themes
